# 4G INGENIERÍA CODE OF CONDUCT

#### Use and Behavior in Common Areas

### **Restrooms and Changing Rooms**

- Respect established hours.
- Take care of the facilities.
- Be mindful of restroom supplies (water, electricity, toilet paper).
- Take care of lockers and respect stored belongings.

#### **Prohibited:**

• Smoking, writing on walls or signage, wasting time, playing games, putting up flyers or advertisements, drug use, leaving food in lockers.

# **Dining Hall Services and Facilities**

- Take care of the facilities.
- Dispose of food waste in designated dispensers.
- Leave your table clean.
- Use the ovens for heating your food.
- Use and take care of the entertainment furniture provided in the dining hall.

#### **Prohibited:**

- Smoking, writing on walls, tables, or signage.
- Making direct complaints to service staff.
- Using any intoxicating substance.

#### **Upstairs Cafeteria Facilities**

#### **Rights:**

- Store your food in the mini-refrigerator.
- Use the cabinets to store non-perishable food, dishes, and utensils.
- Use the water dispenser for consumption.

#### **Prohibited:**

• Leaving spoiled food in the refrigerator, leaving dirty dishes, wasting supplies: water, electricity, soap.

### **Use of Personal Attire and Accessories in Production Lines**

Within company facilities and/or production lines, the use of the following is prohibited:

- Skirts and/or dresses.
- Loose pants, loose blouses or shirts, low-cut blouses, sleeveless blouses, tights, sweatpants, leggings, lycra.
- Pants with rips on the legs that expose skin.
- Cropped blouses or shirts that expose skin.
- Wearing slave bracelets, bracelets, watches (production area).
- Wearing earrings, chains, necklaces, pendants, ribbons, and ties (production area).
- Wearing rings (production area).
- Having long, loose hair (production area). Hair must be fully tied back, in a bun.
- Wearing high heels, ballet flats, sandals, huaraches (production area).
